#### PRODUCT INFORMATION

- LAST CALL ™ F.F. is effective against Fruit Flies of the following species: Mediterranean fruit fly (Ceratitis capitata), Marula fruit fly (Ceratitis cosyra) and Natal fruit fly (Ceratitis rosa)
- It contains an attractant and insecticide which attract fruit flies with attractant where they come into contact with the droplet and a lethal dose of permethrin. As a targeted chemical application, it attracts the pest to the chemical and avoids affecting any biological control agents.
   It reduces the amount of chemical needed per hectare to control the pest and there is no spray drift.
- LAST CALL ™ F.F. is non-phytotoxic for crops.
- LAST CALL ™ F.F. is safe to adult and immature stages of beneficial insects, unless through accidental contact.
- When used as directed, no unwanted residues in or on the harvested crop will occur.
- There is no re-entry interval with the use of LAST CALL ™ F.F.

# **DIRECTIONS FOR USE (USE ONLY AS DIRECTED)**

### **COMPATIBILITY**

LAST CALL ™ F.F. is not mixable with insecticides or fungicides.

The product is applied by hand using a dispenser pre-calibrated to deliver 50 micro liter drops. Depending on the pest pressure apply between 3 000 drops per hectare, giving a dosage of 150 grams of product per hectare.

The disposable dispenser includes the trigger device and the disposable cartridge containing the ready to use LAST CALL ™ F.F. formulation. Prepare the dispenser using the following steps:

- Connect the trigger mechanism and the product containing cylinder. Push the two parts together to break the seal. The two parts are now permanently coupled.
- With the thumb, push the plunger till a drop of grease appears at the tip of the nozzle. The applicator is now ready for use.
- One drop of 50 micro liters will appear for each squeeze of the trigger. Place a droplet on the upper surface of a leaf by touching the leaf surface. Apply droplet in the Top 2/3 of tree to ensure maximum biological activity.
- Distribute droplets evenly throughout area to be treated.

## APPLICATION RATES

- For maximal results the product must be applied at the first signs of the presence of Fruit flies.
- For Fruit fly control at the end of the Citrus season the product must be applied sixteen to twenty weeks before the specific harvest date of the orchard.
- Re-Apply the product within 28 days after last application, with a maximum of five applications per season.
- It is of critical importance to apply a registered insecticide 16 and 8 weeks before harvest on the outside 6 rows, around the block to control any larva and eggs laid.
